# **Meet The Member: Ruth Young, RVT**

I was born in December 1945 and grew up in a small town in central Pennsylvania. There were two veterinarians in my hometown. One had his home and office directly across the street from my home and the other was the local large animal veterinarian. My parents recognized my love for animals but didn't quite know what to do about it. My childhood pets were guppies, hamsters, a cat, a canary, and a dog. As a young teenager, I was allowed to accompany the large animal vet on his Saturday rounds to the local dairy farmers.

Becoming a teenage wife and mother changed my life's course in significant ways. My husband, son and I moved to Florida where I worked in the agricultural chemical industry, earned an Associate degree in Biology and a Bachelor's degree in elementary education. I taught elementary education for seven years before a divorce and remarriage redirected my life once again. Pets of this era included cats, a Boston Terrier, and guinea pigs with their offspring.

I moved to western North Carolina with my second husband in 1981. I continued to teach elementary school and earned my Master's degree in middle grade education. My pets were a dog, rabbit, guinea pig and lovebird. Sometime in the 80's, I began to reflect on my childhood interest in veterinary medicine. As a result of that article, I became an Associate member of NAVTA and subscribed to the Veterinary Technician magazine. I became obsessed with earning a vet tech degree. I called the chairs of various vet tech programs throughout the United States. I took personal leave and visited Dr. Porterfield at Central Carolina Community College. However, there were no veterinary technology programs within driving distance of my home. I would have to leave teaching and relocate if I wanted to pursue that profession. So I began volunteering at the animal hospital close to my home, for the time being.

I read the NAVTA Journal and Veterinary Technician from cover to cover every month. Two prevailing themes recurred on a regular basis in both magazines. One was the issue of the proper title for credentialed veterinary technicians and the other was the issue of salaries. By this time, I had invested considerable time in my teaching career, and I had accumulated a respectable retirement nest egg. I decided to put my pursuit of a veterinary technology career on hold until I retired and hope for a few remaining brain cells to get me through the program, wherever that may be.

After 25 years of teaching elementary and middle school students in Henderson County, I retired in 2006. By then, the veterinary technician program at Asheville-Buncombe Technical Community College had been in place for a few years. My prayers were answered and I could attend college without having to move. I enrolled in the program in 2008 and received my vet tech degree in August 2010. It proved to be the most challenging of the four academic degrees that I had earned over the years. I was almost 65 years old when I became a Registered Veterinary Technician in the state of North Carolina.

Today I am employed as a part time and relief technician at WNC Veterinary Hospital in Arden, North Carolina. I am proud to be a member of a very professional and skilled team of assistants, veterinarians, and one other RVT. I still have a lot to learn and remember. And I owe my progress to the patience and excellent mentorship of the staff. Being a part time employee allows me plenty of time for other activities. I enjoy mountain biking, birding, butterflying, and gardening. I study the flute, play in the hand bell choir at my church and sing in the Magdelen Choir, all women's voices. My family now consists of my cats: Spirit and Camille, my dog: Skippy and my lovebird: Chico.

My professional interests include pet nutrition, pet insurance, emergency medicine, and of course, veterinary technology education. I am excited to have reached my goal as a Registered Veterinary Technician and to have the opportunity to serve the animals and their owners in western North Carolina.

The North Carolina Association of Veterinary Technicians is a non-profit organization designed to support the veterinary technician profession. It began as a small group of dedicated veterinary medical technicians in the Wake County area in the early 1980s. The number of members grew to 62 in 1987 and became the North Carolina Association of Veterinary Technicians. In 1992-93, officers of the NCAVT were instrumental in helping Bill 747 pass in the NC General Assembly. The bill essentially kept the North Carolina Veterinary Practice Act from becoming open to individuals who had not graduated from an AVMA accredited program of veterinary medical technology and successfully completed the National Veterinary Technician Exam and State Boards.


